Important information that applies to all shipments

- * This routing guide applies to all Golf Town orders with a VBA "Golf Town pays freight (Collect)".
 - * PO# must be included on Bill of Lading and/or in reference field for all shipments.
 - * Expedited shipments require written authorization from the Golf Town Logistics Department prior to shipment.
 - * All Domestic shipments require a delivery appt. prior to shipping - Contact 150courtneyparkappts@NLS.ca
 - * Golf Town 3PL address: Golf Town c/o NLS, 150 Courtneypark Dr West, Mississauga ON, L5W 1Y6, Canada
- Domestic Small Parcels (Under 150 cubic lbs) ship via FedEx.
Domestic Shipments from Quebec & Ontario (Over 150 cubic lbs) ship via SureTrack.
Domestic Shipments from outside Quebec & Ontario (Over 150 cubic lbs) ship via NFF.
International Small Parcels from USA only (Under 150 cubic lbs) ship via FedEx.
International Shipments (Over 150 cubic lbs) ships via DSV carriers, arranged through Golf Town.

Domestic shipments within Canada

Small Parcel - under 150 cubic lbs - FedEx

- * Shipments under 150 lbs (Dimensional weight), ship FedEx Ground - Third Party Billing.
- * Third Party Billing Information: Golf Town, 7777 Weston Road, Suite 900, Woodbridge, ON L4L 0G9 Canada
Golf Town FedEx Acct # 733309130
- * Ensure to use ONLY FedEx Ground - Using an incorrect shipping method will be invoiced to the Shipper.
- * Requires a delivery appt. prior to shipping - Contact 150courtneyparkappts@NLS.ca

Shipment originating FROM Ontario and Quebec only - over 150 cubic lbs - SURETRACK

- Ontario and Quebec consignee shipments will be through SureTrack - contact golftownvendors@suretrackcourier.com

- * All Other Province Consignees (outside of Ontario and Quebec) will be through National Fast Freight 905-761-1242 or dispatch@nationalfastfreight.com
 - * Shipment Pick-ups must be scheduled with Carriers by 12 Noon Eastern Time for Same Day Pickup but may be Next Day
 - * Advise carriers and mark BOL with # skids, # of Carton, Units, Weights and All Golf Town PO #'s

Shipment originate FROM OUTSIDE of Ontario & Quebec - over 150 cubic lbs - NFF

- * All Canada LTL shipments will be through National Fast Freight 905-761-1242 or dispatch@nationalfastfreight.com
- * Shipment Pick-ups must be scheduled with N.F.F. by 12 Noon Eastern Time for Same Day Pickup Bill to: Golf Town Limited
Bill all LTL Freight charges to: Golf Town Limited
- * Advise carriers and mark BOL with # skids, # of Carton, Units, Weights and All Golf Town PO #'s
- * Requires a delivery appt. at least 48 hours prior to delivery - Contact 150courtneyparkappts@NLS.ca.

Truckload / Partial Truckload- over 10,000 lbs., over 10 pallets, over 800 cubic feet.

- Ship via FedEx International Economy service only using Account # 733309130. Shipments from Mexico please use acct# 811105074
- * Russell A Farrow will handle the Customs Clearance into Canada please provide copies of Customs Documents to ayrteam2@farrow.com
 - * **Please note Golf Town C/O Russell A Farrow on both the Commercial Invoice and FedEx label in the first reference field.**
 - * Requires a delivery appt. prior to shipping - Contact 150courtneyparkappts@NLS.ca .

Intenational shipment originate from outside of Canada - over 150 cubic lbs - DSV

- * Please contact Amanda Cromwell <acromwell@sportinglifegroup.ca> and Cc imports@SportingLife.ca
- * Please provide P/U Date & Hours, P/U Address & Contact.
- * Please provide Total Pallet# with Dims & Weight, PO#s, Total Carton#, Total Unit#, PO# & Units per Carton(s), Packing slip(s) & Commercial Invoice.
- * Delivery appt will be booked through the carrier or Golf Town.

All custom clearances for Golf Town are completed by Thomas Pint and this must be listed on your shipment documents
